Your sponsor licence

Your sponsor licence number (SLN) is [REDACTED]. Your licence will be valid for four years, subject to compliance with your sponsorship duties, unless it is revoked by us or surrendered by you before then. Your licence start date and end date (the last day before it expires) is displayed on the 'Licence summary' screen in your sponsor management system (SMS) account.

Your allocation for Skilled Worker

The maximum number of Skilled Worker certificates of sponsorship (CoS) you can issue is 1.

Please note you can request additional CoS via the SMS system at any time providing:

- Full job description(s)
- SoC codes.
- Full migrant worker details

If there is insufficient information in your justification for us to make an informed decision, your request will not be granted.

If you assign any Skilled Worker CoS to a migrant worker for a job that does not meet the Skilled Worker requirements on skill level and appropriate rates of pay and/or where there is no genuine vacancy, we will take action against you.

Defined Certificates of Sponsorship (DCoS)

Where you are wanting to assign a certificate of sponsorship to a skilled worker applying for a visa from outside of the UK, you must make an application for a DCoS.

To do this your Level 1 User needs to access their Sponsor Management System account and select the 'apply for defined certificates' option, found within the 'Worker' section.

To support your application for a DCoS, you should include the following information:

- Job Title
- Job Type – You must use the appropriate Standard Occupation Code (SOC) - these can be found at [Immigration Rules Appendix Skilled Occupations](#). If you are not sure which SOC to use, you can use the [Office for National Statistics Occupation Coding Tool](#)
- Dates of employment
- A full job description
- The salary on offer and salary period.
- The weekly hours the worker would be expected to work should be added to the Job description field, even where the salary period has been completed.
- Details of any client contract details/client addresses, where the migrant will be working.
- Professional registration details for the migrant
- Confirmation if the position is a Shortage Occupation, with a qualified job level and whether you are certifying the worker meets the financial requirement of the Immigration Rules.
